Pastor Strope led the prayer.

Pace thanked Pastor Strope and congratulated newly elected committeepersons, Kelsey Bayzick and Jeff Shimp. Solicitor Matt Ritter administered their Oaths of Office.

Pace asked for a motion to open up nominations for Mayor. Bayzick made the motion with Tedesco seconded. Voice Vote: All in favor.

Pace asked for a **nomination for Mayor**. Bayzick nominated Robin Freitag as Mayor. Tedesco spoke highly of Ms. Freitag and seconded the nomination. Voice Vote: All in favor. Freitag takes the Mayor's seat at the table.

Freitag asked for a motion to open up nominations for Vice Mayor. Bayzick makes the motion and Shimp seconded. Voice Vote: All in favor. Freitag asks for a **nomination for Vice Mayor**. Bayzick makes a motion to nominate Tom Tedesco as Vice Mayor. Shimp seconds. Voice Vote: All in favor.

There was discussion regarding the term and amount of the contract. Tedesco suggested modifying the contract on a quarterly basis asking that they sign for a three-month contract and then have it re-evaluated in three months with up to three extensions for a potential end date at the end of the year. Bayzick agreed with this and the general consensus of the committee agrees with this. A new resolution will be prepared with these terms at a monthly pay rate of \$750.00 in an amount not to exceed \$9,000.00. Hitchner will review this proposal with Salmon Ventures to confirm their agreement.
